26,000 COVID-19 Deaths in Nursing Homes Might Spur Federal-State Blame Game

ICT: "Kevin Kavanagh, MD, a member of ICT®'s Editorial Advisory Board, said that the problems with with nursing homes are systemic and existed long before the COVID onslaught and added that the nursing home industry needs to undergo a "significant transformation" in order to prevent a repeat of what happened in the first wave. "Infection control in nursing homes has been almost non-existent for years along with effective regulations to serve as guidance," Kavanagh said. "We are also concerned with a reactionary program of inspections based on non-specific regulations." Kavanagh would like to see a sustained program of oversight using detailed metrics designed to drive a high-quality outcome. "Specifically, there should be reporting of all acquisitions in patients and staff of all dangerous and drug resistant pathogens in nursing homes," Kavanagh said. "Ample PPE and hand washing stations need to be available, along with staff training in infectious disease by a full-time onsite IP professional. Screening of admission for these pathogens and the patient's microbiome needs to take place. Vox: "The new guidance recommends that the general public wear cloth masks made from at least three layers of fabric "on public transport, in shops, or in other confined or crowded environments." Physical distancing, face masks, and eye protection for prevention of COVID-19

The Lancet: "The findings showed a reduction in risk of 82% with a physical distance of 1 m in both health-care and community settings (adjusted odds ratio [aOR] 0.18, 95% CI 0.09-0.38). Every additional 1 m of separation more than doubled the relative protection, with data available up to 3 m The 1–2 m distance rule in most hospital guidelines is based on out-of-date findings from the 1940s, with studies from 2020 showing that large droplets can travel as far as 8 m..."

"This study supports universal face mask use, because masks were equally effective in both health-care and community settings when adjusted for type of mask use. Growing evidence for presymptomatic and asymptomatic transmission of SARS-CoV-2further supports universal face mask use and distancing. In regions with a high incidence of COVID-19, universal face mask use combined with physical distancing could reduce the rate of infection (flatten the curve), even with modestly effective masks." https://www.thelancet.com/journals/lancet/article/PIIS0140-6736(20)31183-1/fulltext

Gargling with bleach? Americans misusing disinfectants to prevent coronavirus, survey finds

(Reuters) - "More than a third of Americans misused cleaners and disinfectants to try to prevent infection by the coronavirus, according to a survey taken shortly after President Donald Trump publicly asked whether injecting such products could treat COVID-19. Washing food with bleach, using household cleaning or disinfectant products on bare skin, and intentionally inhaling or ingesting these products were some of the most commonly reported "high-risk" practices in a May 4 online survey of 502 U.S. adults, the Centers for Disease Control and Prevention (CDC) reported." https://www.reuters.com/article/us-health-coronavirus-disinfectants/gargling-with-bleach-americans-

AIM: "The likelihood that approximately 40% to 45% of those infected with SARS-CoV-2 will remain asymptomatic suggests that the virus might have greater potential than previously estimated to spread silently and deeply through human

Study: Hydroxychloroquine had no benefit for hospitalized Covid-19 patients, possibly closing door to use of drug

A Large Prospective Randomized Control Trial- STAT: "Today's preliminary results from the RECOVERY trial are quite clear – hydroxychloroquine does not reduce the risk of death among hospitalized patients with this new disease," University of Oxford epidemiologist Martin Landray, one of the study's leaders, said in a statement. "This result should change medical practice worldwide and demonstrates the importance of large, randomized trials to inform decisions about both the efficacy and the safety of treatments."

NYT: "Twenty large chains received more than \$5 billion in federal grants even while sitting on more

than \$100 billion in cash.

It is the Providence Health System, one of the country's largest and richest hospital chains. It is sitting on nearly \$12 billion in cash, which it invests, Wall Street-style, in a good year generating more than \$1 billion in profits. And this spring, Providence received at least \$509 million in government funds from capsizing during the coronavirus pandemic."

The airborne lifetime of small speech droplets and their potential importance in SARS-CoV-2 transmission

"Highly sensitive laser light scattering observations have revealed that loud speech can emit thousands of oral fluid droplets per second. In a closed, stagnant air environment, they disappear from the window of view with time constants in the range of 8 to 14 min, which corresponds to droplet nuclei of ca. 4 µm diameter, or 12- to 21-µm droplets prior to dehydration. These observations confirm that there is a substantial probability that normal speaking causes airborne virus transmission in confined environments." https://www.pnas.org/content/early/2020/05/12/2006874117
