New Study: Hydroxychloroquine Works in Monkeys, Not Humans


Thus, at this point, there is no compelling evidence to recommend the use of hydroxychloroquine for clinical

use and several large organizations have suspended research involving this drug. These resources would have been better spent on more promising treatment modalities, such as studying Camostat mesilate or nafamostat mesylate therapy for COVID-19, a compound which has been shown to block TMPRSS2 . Beshear says Kentucky Derby can safely host fans despite COVID-19. Not everyone agrees.

"Not everyone agreed such large gatherings are safe, though those held outdoors are preferable. "Any large gathering of people carries risks," said Dr. Kevin Kavanagh, a retired physician from Somerset, Kentucky, and chairman of the patient advocacy group Health Watch USA. "That risk is lessened outdoors with social distancing and by the wearing masks." However, Kavanagh said in an email that shouting, which often happens during the Derby, can cause the virus to "aerosolize" and "defeat the

safety of a cloth mask" while causing droplets to "travel much further than 6 feet." "In addition, getting into and out of the stands and use of restrooms is problematic," Kavanagh said." Yetter D, Kobin B. Courier Journal. Aug. 12, 2020. https://www.courier-

Kentucky Derby 2020: Why health experts say they agree with Churchill Down's decision.

"Dr. Kevin Kavanagh, a retired Somerset physician who also had warned against allowing fans at the event, praised Friday's decision.

"It sends a very strong message to the community and Kentucky about how serious this pandemic really is," said Kavanagh, chairman of the patient advocacy group Health Watch USA.

Kavanagh said earlier this week that holding the event largely outdoors would have helped. But it still wouldn't account for people entering the racetrack through the building, passing through hallways, placing bets, buying food and drink, using restrooms or otherwise moving about, Kavanagh said. And any cheering or shouting tends to "aerosolize" the virus and increase chances of spread, he said. Though most people who contract the virus don't experience the severe and sometimes fatal symptoms associated with it, that doesn't mean it's not a risk to mingle in a crowd, he said. Even people who appear to have recovered from a less serious case of COVID-19 may be at risk for lasting heart, lung or kidney damage.

"This is one dangerous virus that we don't know much about," Kavanagh said. "This lackadaisical attitude that you can go out and get infected and everything will be fine if you're at low risk is just plain magical thinking.""

"Patients need to be repositioned every two hours to prevent ulcers on the skin, said physician Kevin Kavanagh, founder of patient advocacy group Health Watch USA. Doing so will show staff when patients have soiled their beds, he said.

Daily bathing is necessary to prevent hospital infections, given "the dangerous pathogens and compromised patients," Kavanagh said, but bathing takes so many workers that short-staffed facilities too often don't do it."

Somerset-area legislators decry Beshear's restrictions at Chamber meeting with little use of masks or social distancing

"The lawmakers from the Somerset area spoke to "a packed house" that included "a whole host of the community's business and political leaders," reported Chris Harris of the Somerset Commonwealth Journal. The newspaper's editor, Jeff Neal, told Kentucky Health News that "There wasn't a whole lot of social distancing, and since they were eating, there were not a lot of masks being used." The event concerned Dr. Kevin Kavanagh, a retired Somerset physician who heads Health Watch USA, which focuses on infection control in health care.

"Events like this are very problematic," Kavanagh told Kentucky Health News. "They usually have many cases or none. With the number of individuals present and the prevalence of the virus in Pulaski County, the odds are nothing will happen, but if the virus was present at the event it can be catastrophic. . . . Data from San Quentin Prison sheds doubt on herd immunity with 66% of the population being infected with new cases still occurring. Heart disease is also occurring in all types of COVID-19 patients, even those mildly infected. 60% of patients have changes in their hearts and the fear of myocarditis which is occurring in the young is postponing college sports. Finally, there are long haulers and lasting disability in many who are stricken by this disease. 

Big-10 and PAC-12 Delay Football Season Because of Fears of Myocarditis in Athletes.

"Dr. Curt Daniels of Ohio State University said training athletes who contract coronavirus may develop a rare heart condition requiring them to be sidelined. Of the athletes with coronavirus who were examined at OSU, doctors found between 10 and 13 percent had developed mild cases of myocarditis, which is inflammation of heart muscle. Those athletes performed at "various levels of competition," he said during a Thursday briefing on the state's coronavirus response."

What's the link between myocarditis and COVID-19? A look at the rare heart condition has the college football season in jeopardy.

"I recall even 30 years ago when I was at a conference looking at tennis medicine and how we guide tennis players with flu-like symptoms or cold-like symptoms, we said you absolutely can not train when you have a viral syndrome because there's a risk of myocarditis," he said. "This has been around for a long time. It's here with COVID-19 and we're taking it seriously."

- 1) COVID-19: Survivability And The Prevention of Spread. The course discusses the survivability of SARS-CoV-2 (COVID-19 Virus) in the environment (surfaces, sunlight, humidity, heat) and with different types of hand sanitizers. He also describes research behind the use of masks, eye protection and social distancing along with data indicating the virus may be airborne or aerosolized more commonly than thought. Finally, risks and mitigating strategies are described in various retail and community venues.
- 2) COVID-19 Characteristics of the Virus, Symptoms & Long-Term Disability: The course discusses the characteristics of the SARS-CoV-2 virus along with the body's immune response and dwindling prospects for herd immunity. Characteristics of COVID-19 along with protracted recovery and disability is also discussed.

3) COVID-19: Presentation In Children and When To Open Schools: The course discusses the various presentations of COVID-19 in children, and the risk of childhood transmission to and infections of adults. Current guidance on opening of schools along with international experience on school openings is also discussed.
