### In 2005 President George Bush stated:



### Pandemic and All Hazards Preparedness Act


In December 2006, Congress passed and the President signed the Pandemic and All-Hazards Preparedness Act (PAHPA), Public Law No. 109-417, which has broad implications for the Department of Health and Human Service's (HHS) preparedness and response activities. Among other things, the Act amended the Public Health Service Act to established within the Department a new Assistant Secretary for Preparedness and Response (ASPR); provided new authorities for a number of programs, including the advanced development and acquisitions of medical countermeasures; and called for the establishment of a quadrennial National Health Security Strategy.

The purpose of the Pandemic and All-Hazards Preparedness Act is "to improve the Nation's public health and medical preparedness and response capabilities for emergencies, whether deliberate, accidental, or natural."

- Biomedical Advanced Research and Development Authority (BARDA) and Medical Countermeasures;
- Emergency Support Function (ESF) #8: Public Health and Medical Response: Domestic Programs;
- Emergency Support Function (ESF) #8: Public Health and Medical Response: International Programs;

- National Health Security Strategy (NHSS);
- Situational Awareness: Surveillance, Credentialing, and Telehealth; and




- "The Stockpile Distributed 85 Million N95 Respirators."
- "But the stockpile's reserves were not significantly restored after the 2009 (N1H1) pandemic, in the view of industry and public health experts."
- "The Department of Health and Human Services said last week that the stockpile <u>has</u> about 12 million N95 respirators and 30 million surgical masks —a scant 1 percent of the estimated 3.5 billion masks the nation would need in a severe pandemic. Another 5 million N95 masks in the stockpile are expired."


### Health Watch USA Called For National Reporting System for Dangerous Pathogens



#### Sept 2018: Proposed Policies to Protect Healthcare Workers:

- The screening of patients and healthcare workers for dangerous pathogens, including MRSA, to mitigate the chances of spread to other patients, staff and the community.
- Establish a surveillance system for healthcare workers to determine the extent of occupational acquisition and infections of dangerous pathogens, including MRSA.
- Establish an economic and healthcare safety net for healthcare workers who become infected or colonized with dangerous pathogens, including MRSA.
- Research to promote effective screening and decolonization of healthcare workers for dangerous pathogens, including MRSA.



**Jan. 2019:** Comment on the PACCARB Key Strategies: Goal 1: Slow the emergence of resistant bacteria and prevent the spread of resistant Infections

"In the 2018 Key Strategies the only specific protocol which was mentioned for inclusion in education was hand hygiene. However, much more needs to be specified. In the context of drug resistant bacteria, hand hygiene is a backup measure, since these organisms should not be on a healthcare worker's hands in the first place. The committee should expand its focus on prevention to include patients and healthcare workers to undergo routine active surveillance for carriage of endemic MDROs. A reporting system of healthcare workers' carriage and infections along with an economic safety net for those affected also needs to be implemented."



Jan 2019: Of particular concern are nursing homes, where the reported risk of carriage of resistant bacteria is alarming, well over 50%. And carriage in both the patient and the environment can last for months. The 2019 CDC Threat Assessment lists *Candida auris* and CRE as an urgent threat and MRSA as a severe threat. A slide from this morning's Threat Assessment presentation stated *Candida auris* and CRE need to be contained through an "aggressive approach." However, the current "enhanced barrier precautions" for nursing homes have lowered the standards of control for these three dangerous organisms.

I feel it is of utmost importance that we have an informed public and patients. And that we protect our healthcare workers. Finally, if we are unable or unwilling to allocate the resources to stop this epidemic, we need to at least provide informed consent to patients regarding the risks of these infections and carrier rates within facilities.


### Hospital beds

Total, Per 1 000 inhabitants, 2018 or latest available



The CDC's China headcount has shrunk to around 14 staffers, down from approximately 47 people since President Donald Trump took office in January 2017, the documents show. The four people, who spoke on condition of anonymity, said the losses included epidemiologists and other health professionals.




In my last staff update, I shared that CDC has activated its <u>Emergency Operations Center (EOC)</u> in response to the ongoing <u>2019 novel coronavirus outbreak (2019-nCoV)</u>, which originated in Wuhan, China. CDC, along with the US Department of Health and Human Services, has been actively monitoring the situation for several weeks and is working with the World Health Organization, state and local public health partners and clinicians to respond to this emerging public health threat.

Chinese authorities identified the new coronavirus that resulted in human infections and person-to-person spread in China, and travel-associated coronavirus infections in a growing number of other countries, including five confirmed cases in four US states as of January 28, 2020.

The discovery and outbreak of a new virus among people is always of great public health concern. While we believe the 2019-nCoV poses a very serious public health threat, the virus is not spreading in the U.S. at this time and CDC believes the immediate health risk from 2019-nCoV to the general American public is low. We do expect to find more cases of novel coronavirus in the United States associated with this outbreak and it's likely there will be some person-to-person spread with this virus. CDC's goal is to assure an effective response to this emerging infectious disease, and we expect this will require our concerted effort in partnership with state and local public health officials, the clinical community, and international partners.

Should the White House Order a Travel Ban to Combat a Potential Coronavirus Pandemic?



This historical precedent alone should be sufficient to prove the need to take aggressive action to contain the outbreak. However, current estimates suggest that risk may be even higher. The risk of a severe pandemic rises exponentially with the  $R_0$  value of any disease, which measures how many new people each infected person spreads the disease to, on average. China is reporting a possible coronavirus  $R_0$  of 3 to 5 – which is roughly twice as high as the Swine Flu (1.5) and Spanish Flu (2.2), and in the range of the Bubonic Plague (3.5) and Polio (3.5).

In January 29, 2020, Peter Navarro was reported to have warned the White House that the Coronavirus was possibly infectious as the Bubonic Plague or Polio.

"As of March 23, more than 90 state and local public health labs in 50 states, the District of Columbia, Guam, and Puerto Rico verified they are successfully using [the] diagnostic kits," Haynes said in the statement.

Shortcomings with the tests were first noticed in late January, after the CDC sent an initial batch to 26 public health labs across the country. According to those with knowledge of what unfolded, false-positive reactions emerged at 24 of the 26 labs that first tried out the kits in advance of analyzing samples gathered from patients.

#### New coronavirus cases in the US vs. the EU




#### Daily confirmed new cases (3-day moving average)

A number of new medications have been approved by the FDA for the use in patients with COVID-19. These include:

- 1. Hydroxychloroquine
- 2. Convalescent Serum
- 3. Monoclonal Antibodies
- 4. Remdesvir
- 5. Anticoagulation
- 6. Dexamethasone

## **COVID-19 Therapeutics** Five Treatments Have Been Utilized



- Hydroxychloroquine was initially approved by the FDA for Emergency Use.

Currently there are five prospective randomized controlled trials which have not been able to demonstrate its effectiveness. Three of these trials were double blinded and covered a wide rage of clinical conditions from prophylaxis post exposure to patients with severe COVID-19.

Eli Lilly has produced a neutralizing antibody product which in a phase 2 randomized clinical trial resulted in a 72% decrease in hospitalizations and ER Visits.

Similar to convalescent serum, the product has to be given within three days of diagnosis.

If the company can make enough of this product, it could be a bridge for a vaccine for newly diagnosed patients who are obese or have advanced age and are the most likely to become hospitalized.






