Healthcare Acquired Infections (HAI) – Moving to the forefront of health policy decisions in the US and maybe in Kentucky.

This echoes the call from Health Watch USA for Kentucky to address this issue. Currently, HAI is being addressed in the national healthcare reform bill. The bill however is struggling and passage is uncertain. Many are calling on the State to act.

House's Healthcare Reform Bill Addresses Healthcare Acquired Infections (HAI): HR 3200 has a large section requiring the public reporting of hospital acquired infections. In addition, there is a requirement for Medicaid to adopt Medicare regulations for non-payment of never events.

Both of these sections support two major policy initiatives of Health Watch USA. The section on Medicaid no longer paying for never events, may have some of its origins at the HW USA 2008 conference where this policy was strongly advocated. Consumer Union (Publisher of Consumer Reports) who also attended the conference, actively supported this initiative in 2009. Also, a member of HW USA made several trips to Washington to network with other patient advocacy organizations and Consumer Union; along with advocating for these initiatives.

Although passing a US House Committee to be voted on by the full House nowhere guarantee these sections will become law, it is rewarding to see movement and agreement by many legislators on these initiatives.

Health Care Reform is a hot topic, newly released and compiled data suggests that the current system is high cost with RN's under considerable job stress and insurance premiums and the uninsured climbing. Critics counter, do you want the long wait times of a socialized system. – See points below.

High Registered Nurse Turnover Rate: A recent study funded by the Robert Wood Johnson Foundation found that 26.2% of nurses leave their job within two years. Comments indicated dissatisfaction in primary hospital-based environments. Comments mentioned in the survey were the need for higher nurse-to-patient ratios and decreases in mandatory overtime. This has financial implications, since a high nurse turnover is very costly to institutions. More importantly, it raises serious concerns regarding patient safety.
