Health Care Waste - High

Thomson Reuters estimates that the waste in healthcare is between \$600 billion and \$850 billion annually. The breakdown is as follows:

40% Unnecessary Care

19% Fraud

17% Administrative inefficiency

12% Healthcare Provider Errors

6% Preventable Conditions

6% Lack of Care Coordination

Kentucky ranks 45th (at the bottom) on healthcare relative to achievable benchmarks for 38 indicators of access, quality, costs, and health outcomes. In 2007, Kentucky ranked 43^{ed} on the same measurements. This indicates that things may be getting worse. Kentucky is in the bottom quartile for both affordability of care and healthy living.

Improvements in healthcare is attributed to a number of factors. The impact of Medicare's transparency initiatives to measure and benchmark the quality of hospital care. Declines in rates of pressure ulcers and restraints in nursing homes, and patient mortality was attributed to public reporting and collaborative improvement initiatives.
