### Public and Government Pressure and Shift in Attitudes have Reduced Hospital Infections in Massachusetts.

A reduction in rates of ventilator acquired pneumonia was observed. In addition, 50 percent reductions in infections after orthpedic cases and 80% reductions in MRSA were reported by some facilities. Senior Vice President at the Institute for Healthcare Improvement stated, "The excuses vanished,"

In California, "from 1999 to 2007, the number of (MRSA) cases increased from 13,000 to 52,000. The largest increase in MRSA cases came from home admissions in the young to mid-adult range with skin infections."
