Veterans Administration MRSA Study Results Obtained by HW USA.

HW USA has obtained the results of the VA MRSA prevention study. Data was collected while patients were treated under VHA Directive 2007-002 which mandated universal active surveillance/screening of all patients admitted to the VA Hospital (except psychiatric units), contact precautions and hand hygiene. <u>http://www.healthwatchusa.org/mrsa/pdf_downloads/VHA-MRSA-Directive-2007-002.pdf</u> Results are as follows:

"The most recent Veteran Health Administration (VHA) evaluation of the data for Methicillin-Resistant Staphylococcus Aureus (MRSA) Healthcare Associated Infections (HAI's) shows the following:

• MRSA HAI rates in the Intensive Care Unit (ICU) setting declined 76% (from 1.62/1,000 Bed Days of Care (BDOC) in October 2007 to 0.39/1,000 BDOC in June 2009)

• MRSA HAI rates in the non-ICU setting declined 28% (from 0.46/1,000 BDOC in October 2007 to 0.33/1,000 BDOC in June 2009)

Healthcare Acquired Infections:

Congressional testimony by Thomas Friedmen, MD, MPH Director of the CDC regarding antibiotic resistance and the threat to health and the positive results the Pittsburg VA MRSA study had on prevention of infections. "Disease surveillance is a core CDC activity. CDC uses surveillance systems to assess and monitor the scope, magnitude and trends of the antibiotic resistance problem. Surveillance data are used not only to monitor resistance rates but are also used to drive and direct prevention efforts, determine treatment recommendations, guide new drug development, and evaluate the effectiveness of prevention programs."
