### **HW USA is Helping to Formulate National Policy on HAI**



Health Watch USA was invited to the "Progress Toward Eliminating Healthcare Associated Infections" summit in Arlington, VA. Pictured on the right is Assistant Deputy Secretary Don Wright.



One of the interesting facts is that 3000 acute care facilities which represent well over 50% of all hospitals in the nation are now reporting Hospital Acquired Infections using the National Patient Safety Network.

Goals are a 50% reduction in MRSA and CLABSI (Central Line Associated Blood Stream Infections) by 2013; a 25% reduction in CAUTI (Catheter Associated Urinary Tract Infections) and a 30% reduction in C. Diff infections.

Multiple round table sessions were held to outline priorities and barriers to achieving these goals.

However, hip and knee infections are increasing at an exponential rate. CLABSI are now required reporting for participation in the prospective payment system, which almost all hospitals participate in. In addition, surgical site infections will be required to be report on Jan 1, 2012. These are deep fascial or organ space infections, not skin infection.

### October 2, 1020 HW USA Meeting

Rosemary Gibson noted author of the "Wall of Silence" and the "Treatment Trap" presented via SKYPE at HW USA's Oct 2nd Meeting. She pointed out that there are three types of Quality Problems in medicine. The first is underutilization of needed treatment and tests, the second are medical errors and the third is overuse of unnecessary



tests. The latter can be just as devastating to the patient as the first. (Picture on the right shows HW USA members Pat Tanner and Joe Graber in from of Rosemary Gibson presenting via SKYPE).

An example of over use of medical tests is the recent prob by the FDA into the alleged pressuring of scientists for approval of high tech CT Scanners.

Little has been done since the publication of the Institute of



Medicine's report in 2000 which found that approximately 98,000 patients die each year from hospital acquired conditions. The CDC estimates that there are 1.7 million hospital acquired infections each year that cause nearly 100,000 deaths, which costs our US healthcare system between 28 billion to 33 billion dollars each year. Each infection can produce an additional cost of hospitalization of between \$32,000 and \$38,656.
