More than 50% of nurses surveyed stated they had witnessed shortcuts leading to near

misses or patient harm. Only 17% of these nurses discussed their concerns with colleagues. (The American Association of Critical-Care Nurses and the Association of Perioperative Registered Nurses partnered with VitalSmarts for this study.)
