New Report on Use of Surveillance Cultures

Dr William Jarvis on MRSA Colonization and Risk of Infection:

This report discusses a study by Dr. Gupta which found that the use of Vancomyin prophylaxis prior to surgery in the absence of MRSA colonization was associated with an increase risk in infections. 6.6% of patients were found to be MRSA carriers. And that MRSA carriage was associated with an increase risk of infection. States that the research data provides strong support for active MRSA Surveillance of preoperative patients. http://www.medscape.com/viewarticle/755905
