

CMS Announces a Delay in Implementation of ICD-10 Billing

This have several ramifications. One is that the software to allow for ICD-10 reporting complies with Version 5010 transaction standards. It is this software version which will allow CMS to capture 25 submitted diagnostic codes. With older billing systems, CMS can only capture the first 9 of 25 submitted diagnostic codes.(1) This may affect the accuracy of Hospital Acquired Condition reporting.

CMS only Requires Infection Rates for Abdominal Hysterectomies and Colon Surgery to be Reported.

Infection rates for C-Sections should also be reported since this is the most common surgery performed at hospitals and the measurement technique should be similar to Abdominal Hysterectomies.

C-Sections are also an over utilized operation with significant variation in rates.

New AHRQ Report Shows There is Still a Punitive Safety Culture

"Nonpunitive Response to Error (average 44 percent positive response)—the extent to which staff feel that their mistakes and event reports are not held against them and that mistakes are not kept in their personnel file."
