US DOJ: "The settlement resolves allegations that, under agreements entered into in 2008 by CareFusion's predecessor, CareFusion paid \$11.6 million in kickbacks to Dr. Charles Denham while Denham served as the co-chair of the Safe Practices Committee at the National Quality Forum, a non-profit organization that reviews, endorses and recommends standardized health care performance measures and practices. "

Hospital Charge to Cost Ratios

"With growing national attention to hospital pricing practices, new data released by the nation's largest nurses organization today showed that hospital charges continue to skyrocket with some U.S. hospitals charging more than ten times their cost – nearly \$1,200 for every \$100 of their total costs.

Kentucky has a hospital (Paul B Hall) reported to have the second highest charge to cost ratio in the nation.
