# Commentary on the Dr. Charles Denham ChloraPrep Controversy and the Journal of Patient Safety (JPS).


This article looks at alleged conflicts of interest that arose out of the \$50 Million Dollar Department of Justice Settlement with CareFusion over their product ChloraPrep (Chlorhexidine and Alcohol antiseptic) and an alleged \$11 million dollar kickback. "Journals for quality and patient safety in general, and JPS in particular need to take steps to assure that they can avoid future entanglements with conflicts of interest. This is crucial if the articles they publish are to remain

credible and trustworthy. For this reason, there have already been changes at the Journal."
