
- Slow the Development of Resistant Bacteria and Prevent the Spread of Resistant Infections

### **Questions Raised Regarding CEO Compensation**

"Williams earned an average compensation of \$3.5 million a year between 2011 and 2013, based on the federal tax returns that Norton filed, the newspaper states. Chief Operating Officer Russell Cox was paid \$1.5 million annually over that same time period and Chief Financial Officer Michael Gough, \$1.2 million.
