

### Single-Payer Health Care May Emerge As Best Option

How would the ACA be fixed? Returning to the free market is not likely; few legislators have the power or will to enact the below six changes. Returning to a free-market system will be more difficult than just saying "repeal Obamacare." The following would have to be accomplished to create a free market:

■ Break up the large hospital corporate oligopolies.

■ Reverse the massive physician employment by hospitals, including the

elimination of non-compete clauses.

■ Eliminate payment inequities (as much as 100 percent) for different provider types who provide essentially the same service.

- Inform patients of the cost of a service. Costs can vary more than five times over among providers.
- Inform patients of the quality of care. This would be a herculean task, judging from the health-care industry's resistance to publicly reporting outbreaks of untreatable bacteria in their facilities.
- Repeal insurance companies' anti-trust exemption.
