Safety Oversight of Medical Devices is Being Called Into Question:

Over the last year HW USA has disseminated abundant information on the risks of implantable medical devices. We have focused on three areas which we felt represent just the tip of the iceberg and illustrates the problems with safety monitoring of medical devices. (Morcellators, GI Endoscopes, and Metal on Metal Hip Implants).

Science publication is hopelessly compromised, say journal editors

The Lancet's April 11, 2015, Dr. Richard Horton, editor-in-chief, wrote: "The case against science is straightforward: much of the scientific literature, perhaps half, may simply be untrue. Afflicted by studies with small sample sizes, tiny effects, invalid exploratory analyses, and flagrant conflicts of interest, together with an obsession for pursuing fashionable trends of dubious importance, science has taken a turn towards darkness. A New U.S. Supreme Court Ruling States Industrial Boards Cannot be Controlled by

Participants They Regulates. Thus, Physicians on Medical Boards must comprise less than 50% of the voting membership.

"In February 2015, the U.S. Supreme Court ruled in the case of North Carolina State Board of Dental Examiners v. Federal Trade Commission. The actual court ruling is so wonky that it even went over the head of most policy wonks. It says, basically, that state agencies cannot be controlled by "active participants" in the regulated trade or profession lest they run afoul of antitrust laws. "

New Study Supports the Importance of Contact Precautions

"MRSA transmission from MRSA-positive residents to HCW gown and gloves is substantial; high-contact activities of daily living confer the highest risk. These activities do not involve overt contact with body fluids, skin breakdown, or mucous membranes, which suggests the need to modify current standards of care involving the use of gowns and gloves in the nursing home setting."
