An update on control of central line infections, stated that programs which participates in CUSP the percentage of facilities with zero infections increased from 30% to 60% and this zero is achievable.

A new study estimates the incidence of CRE is 2.93 CRE cases per 100,000 people over a two year period. That equates to over 4500 cases in the United States per year. A far cry for a rare case. #### New Study Finds MRSA Can Live For Years in a Patient's Home

USA300, an extremely virulent strain of MRSA is known to cause necrotizing pneumonia and endocarditis. Researchers have concluded that this strain can live in houses for 2.33 to 8.55 years, underscoring the importance of viewing the home as a long-term reservoir and the need for decontamination of a patient's environment.
