C. Diff: Deadly Infection on the Rise in U.S. Hospitals

The infection, called C. diff (Clostridium difficile) sickened 101,074 hospital patients in 2014, the most recent data available, according to a March report from the CDC. Other research shows that overall about 450,000 people a year, inside and out of hospitals, are sickened by the infection, and it contributes to the death of about 29,000 people.



CDC Letter & Authors' Response to Letter Regarding "Questionable validity of the catheter-associated urinary tract infection metric used for value-based purchasing" Now Available FREE ACCESS !!!

AJIC: Author's response to CDC's letter regarding changes in metrics. "(Halpin et al) describes the many institutions that have implemented initiatives in the prevention of Catheter Associated Urinary Tract Infections (CAUTIs) but paradoxically the CDC NHSN data indicates the rates of CAUTIs are not decreasing. Clearly, either there are problems with the metric and/or data; or gains have not taken place. The 2014 CAUTI data is currently available and the AHRQ metric indicates there are 7.6 CAUTI infections per 1000 discharges, a 38% decrease over the 2010 baseline. The CDC/NHSN metric indicates there is a 5% increase in CAUTIs based on the average hospital performance (N=2268, acquisition dates 1/1/2014 to 12/31/2014) compared to a 2009 baseline. This is a large discrepancy in findings."

Effectiveness of Chlorhexidine Wipes for the Prevention of Multidrug-Resistant Bacterial Colonization and Hospital-Acquired Infections in Intensive Care Unit Patients: A Randomized Trial in Thailand

This was a small study, but the chlorhexidine group did worse: "Favorable events at day 14 were observed in 34.8% of patients in the control group and 28.6% in the chlorhexidine group (P=.79). CONCLUSION The effectiveness of 2% chlorhexidine-impregnated washcloths for the prevention of MDR gram-negative bacteria colonization and hospital-acquired infection in adult patients in ICU was not proven." http://www.ncbi.nlm.nih.gov/pubmed/26894621
