We just did what was right and kept the patient at the center and didn't stop until the

patient was made whole (to the extent possible)."

#### Researchers Discover Dangerous Bacteria in Pennsylvania Resistant to All Antibiotics

last resort, an alarming development that the top U.S. public health official said could mean "the end of the road" for antibiotics."

This dangerous bacterial enzyme was isolated in the urine of a woman in the United States and in a pig on a farm in Pennsylvania. The enzyme breaks down the antibiotic of last resort "Colistin".

Colistin is not used in agriculture in the United States. It is however used in China. <u>http://phenomena.nationalgeographic.com/2015/11/21/mcr-gene-colistin/</u>

However, a similar antibiotic which could also stimulate the development of the gene is polymixin b. This drug is found in almost everyone's medicine cabinet in the form of Polysporin Ointment and Triple Antibiotic Ointment.

Here is the initial response from the U.S. Department of Health and Human Services:

#### Proactive Efforts by U.S. Federal Agencies Enable Early Detection of New Antibiotic Resistance:

"Colistin is rarely used in human medicine compared to other antibiotics. It is often used to treat multi-drug resistant infections and its use is increasing. It is not used in animals in this country. As such, the new detection underscores the urgent need for more research in this area, and that's why the President's 2017 budget request also calls for Congress to fund the Agriculture and Food Research Initiative at its full level, allowing our nation's best and brightest scientists to help the NARMS partners get ahead of the fight to keep antibiotics effective and available. Earlier this month, USDA announced that it is seeking applications for \$6 million in research funding to address antibiotic resistance through this program, but currently USDA must leave nine in ten applications for AFRI grants unfunded, keeping meaningful projects off the table."
