

Bacteria that can't be treated by any antibiotic now in U.S.; Kentucky ranks first in one type of antibiotic-resistant infection

Kentucky Health News: "Dr. Kevin Kavanagh, a retired physician and chairman of Health Watch USA, said he isn't convinced that the U.S. pig was infected by livestock from China. He noted that colistin is commonly used to treat CRE, cystic fibrosis

and that a form of colistin can be found in many over-the-counter topical antibiotics." Click on picture to enlarge

""It's probably more likely that the pig in the U.S. obtained this from the farmer's medicine cabinet than from another pig in China," Kavanagh said."

"Kentucky has one of the highest prescribing rates of antibiotics in the nation and also leads the nation in another antibiotic resistant infection called MRSA (methicillin-resistant staphylococcus aureus)."

""Overuse of antibiotics has got to stop," says Kavanagh said. "The use of antibiotics needs to be curtailed to only when it is necessary. ... Every time you take an antibiotic you remove your good bacteria and run a real risk of activating a superbug in your body which can cause you extreme harm and even death. You should only take antibiotics when you have to take them.""

Flawed Legislation to Correct Hospital Outpatient Facility Fees, Which are Costing Medicare Billions.

If hospitals have not aggressively purchased physician practices, the legislation gives them incentive to do so now, said Kevin Kavanagh, of Health Watch USA, a Kentucky-based patient advocacy and research group. "If the design was to lower fees, it's not doing that," (Dr). Kavanagh said. "It is hurrying up the process by setting a deadline. It did not unravel the damage that's already been done."

Medical Device Guardians Act Filed In Congress

On June 8, 2016, a bipartisan bill was proposed by U.S. Representatives Mike Fitzpatrick (R-PA), Louise Slaughter (D-NY) and Ryan Zinke (R-MT). This bill, the "Medical Device Guardians Act" (H.R. 5404), was named in honor of the hundreds, if not thousands, of women whose lives were devastated or ended prematurely, using a flawed medical device known as a Power Morcellator.
