U.S. health reform now needs reforming - OpEd.



Lexington Herald Leader: "Health care comprises almost 18 percent of the United States' gross domestic product — a figure touted by the industry as testament to its importance to society and contribution to our standard of living. But this statistic paints a rosy picture and hides a bitter truth. In 2015, we spent \$24,691 for each family — almost half of the average family income of \$54,000. The Affordable Care Act is at risk of becoming anything but affordable. Its name should be changed to the Accountable Care Act, since the ACA has good provisions which promote health-care transparency and quality. But as it stands, our health-care delivery system is again in desperate need of



Commonwealth Fund: "Overall, insurers' premium revenue from individual market plans increased 97 percent between 2012 and 2014, owing to the large number of new enrollees through the marketplaces. Profits varied, however, with a third of insurers remaining or becoming profitable and two-thirds losing money. The majority of unprofitable insurers also did not turn a profit the previous year, before the ACA was implemented, the authors

Is the Presidential Advisory Council on Combating Antibiotic Resistance missing opportunities?

American Journal of Infection Control: "Antimicrobial resistance is a critically important impending public health crisis that not only threatens the treatment of infectious disease, but also the very foundations of modern health care from transplantation to cancer chemotherapy. Many types of surgeries and the health of immunocompromised patients, including those with diabetes, will be placed at risk if antibiotics are no longer able to prevent or treat infections."

"Similar to other industrialized countries with national healthcare, the United States needs to set prioritized standards which can be

implemented with near uniformity across our healthcare system. This will not be an easy task, but how the leaders in public health and infectious disease address this epidemic at this juncture will be studied for millennia and their actions dissected for centuries to come. Their decisions will determine their legacy and the future of modern health care as a whole."

"Infection prevention strategies (e.g., vaccination, reducing transmission of pathogens in health care environments, and appropriate management of chronic diseases) are likely to have a substantial impact on reducing sepsis. CDC, in partnership with organizations representing clinicians, patients, and other

CMS Issues Proposed Rule that Prohibits Discrimination, Reduces Hospital-Acquired Conditions, and Promotes Antibiotic Stewardship in Hospitals

"...the Centers for Medicare & Medicaid Services (CMS) announced that it is proposing to update the requirements that hospitals and critical access hospitals (CAHs) must meet to participate in Medicare and Medicaid. The proposed changes to the requirements, formally called the Conditions of Participation, would modernize and revise the requirements to reflect current standards of practice and support improvements in quality of care by:

- Reducing readmissions;
- Reducing barriers to care;
- Reducing the incidence of hospital-acquired conditions (including healthcare-associated infections);
- Improving the use of antibiotics (including the potential for reduced antibiotic resistance);
- · Addressing workforce shortage issues; and
- Improving patient protections. "
