Neuropsychiatric symptoms following metal-on-metal implant failure with cobalt and chromium toxicity

BMC Psychiatry: "We found neurocognitive and depressive deficits after cobalt and chromium

metallosis following MoM (metal-on-metal) implant failure. Larger studies of neurocognitive effects are indicated in this group. There may be implications for public health."
