Early Warning Signs Were Missed With Gastric Banding

"Of the \$2.1 billion spent on the gastric band device during this period, \$820 million was spent on device-related reoperations.1 Perhaps of greater concern is that the trend of increasing payments to remove or revise the device appears clear as early as 2009, when payments for reoperations totaled more than 30% of annual spending on the gastric band device "

How the ACA's Changes to Medicaid Will Affect Hospital Finances in Every State

"The hospitals in the District of Columbia and the 31 states that expanded Medicaid are projected to see a 78 percent increase in uncompensated care costs between 2017 and 2026. Eleven of these states will see uncompensated care costs at least double between 2017 and 2026. For example, Nevada hospitals will see a 98 percent increase, West Virginia a 122 percent increase, and Kentucky a 165 percent increase."
