#### US Antibiotic-Resistant Infection Treatment Costs Doubled Between 2002 And 2014 - Now exceeding 2 Billion Dollars.

"We found that antibiotic resistance added \$1,383 to the cost of treating a patient with a bacterial infection. Using our estimate of the number of such infections in 2014, this amounts to a national cost of \$2.2 billion annually."
