

## CDC Releases the 2019 Threat Assessment for Drug Resistant Bacteria.

"The Centers for Disease Control and Prevention (CDC) today released its updated <u>Antibiotic Resistance Threats in the United States</u> (AR Threats Report) indicating that antibiotic-resistant bacteria and fungi cause more than 2.8 million infections and 35,000 deaths in the United States each year.

That means, on average, someone in the United States gets an antibiotic-resistant infection every 11 seconds and every 15 minutes someone dies. When *Clostridioides difficile*, a bacterium which is not typically resistant but can cause deadly diarrhea and is associated with antibiotic use, is added to these, the U.S. toll of all the threats in the report exceeds 3 million infections and 48,000 deaths." <a href="https://www.cdc.gov/drugresistance/biggest-threats.html">https://www.cdc.gov/drugresistance/biggest-threats.html</a>

These mistakes are costly – estimated at over \$21 billion ... As described by the Nursing Home Law Center, federal law requires skilled nursing facilities to keep errors within a 5% margin."
